Parents play a significant role in teen's driving behaviors and habits. With motor vehicle crashes being a leading cause of injury and fatality for young people in the United States, it is important that parents know what they can do to keep teen drivers safe on the roads. Raise Your Voice is open to groups comprised of at least five high school aged students and one adult advisor anywhere in Alaska.

Grant Requirements

Grant Agreement

The Grant Agreement is an agreement between the participating organization (grantee) and the Alaska Injury Prevention Center (AIPC). By signing this agreement, the grantee agrees to undertake the grant requirements and AIPC agrees to write a \$500 check to the organization when the grant requirements are successfully completed. The Grant Agreement is to be signed and returned by **January 20, 2017**.

Media Releases

AIPC needs permission to use a person's photograph, voice, and/or name in various media projects. Each participating member of the group will need to read and complete the media release forms. Media Releases are to be signed and returned to AIPC by **January 20th**.

Meetings

Each group will meet, either in person or over video chat, with AIPC a total of three times throughout the process. AIPC is available to meet student groups at their school, an agreed upon public meeting place, or at the AIPC office. These meetings will be scheduled shortly after teams are notified of their selection to Raise Your Voice.

Drafts

Each group will be required to turn in a storyboard draft and a draft of their video. These drafts are due on **January 20th** and **February 3rd**. AIPC will supply feedback on each draft in a timely manner.

Video

Each team's video should be no longer than 45 seconds. Videos are due to AIPC no later than **February 17th**. Videos may be submitted to AIPC via email, through Dropbox, Google Drive, WeTransfer, or delivered to AIPC on a USB drive. Videos may be used by AIPC in trainings, community events, or other public arenas. Grantees will always be cited as the developers and creators of their videos.

Share

Grantees are required to share their videos with parents via a school electronic newsletter, school website, official school social media, or through other agreed upon means. Groups will also share a survey link. Groups are also required to share their videos with parents through at least one event such as Parent-Teacher Conferences or other school event attended by parents. Students will also distribute Teen/Parent Safe Driving Materials supplied by AIPC. Groups will complete this by **March 10, 2016**.

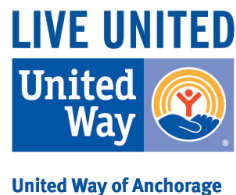

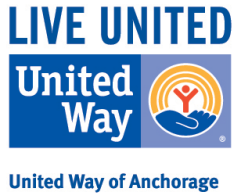
What do you think are the two biggest safety concerns for teen drivers in your school or community?
